New Business:

Lee Morgan said that nominations are due every 2 years. Positions to be voted on are Lee Morgan for Chairman; vice chairman Eric resigned so vacant; Rose Connolly for secretary. Need vice position only to approve.

Aug 2017 Dane went to VSO School. He had a \$14.12/hr raise 37 and half hours per week. Dane has now worked 7 half years for Sangamon County. The board voted to give him a raise to \$15/hr. Recommended and approved.

Kim met with Al Reynolds from the state DAV regarding a van. Our van transportation is falling apart. Have to have ½ the money for a Ford transit by 2019 for the county to match the other half. We need about \$15-16,000 we need our half first. It must be handicap accessible. In the past, John Ferrell solicited money. Bill Woollen suggested a chili cook off or quarter auction in March, April or May.

DAV 2 weeks ago new DAV if enough new members to participate at least new 15 (50?) names. Members at Large will not necessarily be accepted into new chapter. The new post must start with new members. To become a member, they must have a 10% disability requirement to join.
